Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peacably to assemble, and to petition the Government for a redress of grievances.

CAMPUS GROUP PROTECTIONS

There are certain actions public schools cannot take against student groups, regardless of their attempted justifications.

Your School CANNOT:

- Prevent you from starting a campus group because it is religious, political, controversial, or "triggering."
- · Require trigger warnings.
- · Create "free speech zones" outside.
- Read your personal email without reasonable suspicion and a police warrant.
 This also includes your group's email (unless the account ends in ".edu").
- Fire staff for advising and/or sponsoring your group.
- Charge security fees for events based on how controversial they perceive the speakers to be.
- Distribute or not distribute student fees and funds with bias.
- Cancel or move events because of extreme opposition.
- Unnecessarily extend the approval process or be unresponsive.

THIS IS FREE SPEECH

Campus Group's Rights:

You have the right to:

- Form a student group if other students can.
- Equal access to funding and other campus resources.
- Know where and how your student fees are being spent.
- Insist on a written denial (an explanation as to why your school took certain action against your group).
- Have your school help you find an advisor if it is a requirement for starting a group.
- Host a graphic image display of aborted children on a public campus.
- Protest and counsel on the sidewalks in front of a Planned Parenthood.
- Chalk pro-life messages on public campus grounds (assuming that other groups are allowed to chalk messages).
 - Use content that your school's administration deems 'harmful,' 'uncivil,' 'offensive,' or 'hate speech.'

CONSTITUTIONAL SPEECH RESTRICTIONS MUST:

- Apply to all groups equally.
- Not consider what a speaker is saying or what he/she believes.
- Not target a specific group based on views.
- Be free of restrictions based on how other people might react.
- *These are just the minimum requirements. Some rules that meet these criteria may still be unconstitutional.

Vandalism and theft of displays and signs.



Threats of violence.
